- 2. Improvement work is a continuous task. I will convene a meeting in late June to invite senior managers and EPG to participate. I will listen to the EPG team leader at the meeting. After this evaluation process, I will do organizational process improvement. What matters are presented, and the specific cost and effectiveness analysis;
- 3. The above improvement meeting and work will inevitably become a very important part of my annual, semi-annual and quarterly work. I will pay close attention to the data and effectiveness analysis generated during the process improvement process.
