- 1. The essence of CMMI5 lies in: accurate prediction, control and measurement. Therefore, in the future, we need to add more measurement dimensions (such as costs and profits), and continue to improve data prediction models and methods (such as Factors increasing CPK in the model)
- 2、应将 CMMI 理论和实际联系在一起,应充分考虑客户诉求给项目管理带来的风险和影响,增加客户反馈作为流程改进建议的收集渠道。
- 2. The theory and practice of CMMI should be linked together, and the risks and impact of the customer's appeal on project management should be fully considered, and customer feedback should be increased as a channel for collecting process improvement suggestions.
- 3、拥抱变化。不同的业务类型应采用不同的 QA 检查单,应增加针对不同业务类型的基线和模板。
- 3. Embrace change. Different business types should have different QA checklists, and baselines and templates for different business types should be added.
- 4、不断完善细节,增加更多关于干系人以及过程改进建议的属性,如增加 联系人和重要级别分类。
- 4. Continuously improve the details and add more attributes related to stakeholders and process improvement suggestions, such as

adding contacts and important level categories.

5、可以预见,此次疫情将深刻的改变人们的工作和生活方式。应在风险库中增加疫情风险及应对措施,同时,针对远程办公和远程协作,需要制定相应的流程和指南。

5. It is foreseeable that this epidemic will profoundly change people's work and lifestyle. The epidemic risk and response measures should be added to the risk database. At the same time, for remote office and remote collaboration, corresponding processes and guidelines need to be developed.
