In this appraisal, your improvement suggestions have made us realize our process deficiencies. Through your vivid guidance, our team has deeply understood the essence of high maturity, which is summarized as follows:

1、深入了解 PPM 模型更有效合理的使用方法。在建立 PPB 时,应考虑资源变动、需求变更等方面的度量项, PPM 模型应该包含需求、设计、编码、测试等多

个各阶段中的影响因素。

- 1. Explore more effective and reasonable use of the PPM. When establishing a PPB, measures such as resource changes and requirement changes should be considered. The PPM should include the factors in various stages such as requirements, design, coding, and testing.
- 2、体会了 Dephi 和三点估算方法的差别,了解到在项目估算时对参与人员设置权重可以提高估计的精致。
- 2. I realized the difference between Dephi and the triangular distribution estimation method. I learned that setting weights for average during project estimation can improve accuracy.
- 3、对组织级 PPM 模型的指标项及定义进行完善,增加工作量超期百分比,组织明确超期的具体阈值和建议。
- 3. Improve the indicators and definitions of PPM, introduce the trigger for effort deviation, and set corrective plans.
- 4、QA 和 CM 在项目审计工作中存在重复的工作问题,需要协同办公,即可 降低人力成本,也降低人员不在或者离职的风险,保证整个项目正常运行。
- 4. Some audit activities are overlapping for CM and QA, which in some cases can be merged to reduce labor costs, reduce the risk of staff absence or resignation, and ensure the normal operation of the entire project.
- 5、PPQA 不仅要注重过程检查还要注重产品或项目的检查,需要单独制定产品或项目的检查单,由高层经理审核。
- 5. PPQA should not only pay attention to the process audit but also to the work products. It is necessary to develop a specific checklist for projects, which are reviewed by senior managers..
